Founding principles and landscape of the Chair

Ever since its creation in 2015, the Governance and Regulation Chair has been **a platform** for **stakeholders and experts** to consider and discuss the institutional framing, processes, and delivery of regulation.

Drawing on **academic networks and teams from Paris Dauphine-PSL University** and hosted by the Dauphine Foundation, this Chair is also home to **the Club of Regulators**, bringing together a **broad spectrum of French regulatory authorities**.

Dedicated to the economic, technical, organisational, and institutional challenges faced by various players involved in market and industry governance, the Chair delivers its services within a **network of academics, experts, entrepreneurs, and industrialists, as well as government decision-makers in France and abroad.**

Specific activities

in France and abroad for an eco-system consisting of **academics** and public and private **decision makers**.

The Chair is headed by its scientific director **Éric Brousseau** and its activities are coordinated by its general delegate. The research is conducted by more than ten junior researchers and about thirty senior researchers representing

various academic institutions and government bodies from around the world. A support team is dedicated to communications, event planning, and administration.

Organisation of the Chair's activities

- **Research** that mobilises junior and senior researchers working on doctoral or collaborative projects.
- **Training**, for students and professionals, to introduce students, managers, and young researchers to the issues inherent in economic regulation.
- **A contribution to the public conversation** that fosters a dialogue between the stakeholders and shines a spotlight on the collective challenges that regulation must address.

Work perspectives

The **Chair's research reflect the main economic and social challenges, and focuses on government policies and corporate strategies** having an incidence on economic governance and sectoral regulation.

Working groups and projects mobilize academics, experts, operators, regulators, and public institutions, generating synergies across research projects and anchoring them in real-world concerns. These **working groups and projects** are structured around the major vectors of contemporary socio-economic transformation, namely **digital transformation, ecological transition and good governance issues**. The latter constitute the three main research programmes of the Chair.

The Chair's partners

The Chair is based on a genuine **partnership** with its **sponsors**, who **enrich university research** by contributing with their experience, providing data, and encouraging the formulation of actionable conclusions.

Being a sponsor of the Chair means:

- **Providing support** to scientific approaches to enlightened economic activity and government action addressing issues of governance and regulation, in particular in light of the ecologic and digital revolutions.
- **Directly participating in producing the knowledge** that is the source of this light, which is also likely to inform reflection on reforms and best practices and **yield compound benefits**.
- Taking advantage of a neutral platform for thinking and talking on which **to meet with regulated operators and public regulators** and to share analyses and methods based on various cross-sectoral experiences; to implement innovative solutions that will improve the efficiency of the regulatory systems concerned.
- **Benefiting from a pool of competencies** that can be mobilized to address specific issues.

Concretely, the Chair's sponsors:

- First and foremost, have a seat on the **steering committee** allowing them to have a say in the programming of the Chair's activities.
- Are **involved in all activities** (conferences, seminars, task forces, training, etc.) and **their logo** is consistently associated with any communications relative to the latter.
- Over the duration of their participation in various activities they develop **cooperative relationships** with all stakeholders: representatives of academia and governmental and private sectors decision-makers.
- Are able to develop **supplementary and targeted projects** in consulting and training or research, such as the CIFRE agreements allowing doctoral students to write their theses while working for companies, or with professional groups under academic supervision provided by a specialised research group in the University.
- Benefit from a **tax deduction amounting to 60%** of their donation to the Dauphine Foundation. The commitment required from each sponsor is 80 k€/year for five years.
